**DIRECTIONS:**

Adults and children over 6 years old:

**For acute treatment** of urinary tract discomfort or urinary tract infections: Take one (1) capsule twice a day for 10 days.

**For reoccurring** urinary tract infections: Take one to two (1 - 2) capsule/s once a day.
